



## XVIII FUNDACIÓN DEXEUS MUJER PRIZE'S RULES – 2023

1. PRIZE awarded to the person, persons, research team or institution whose professional trajectory or continued line of research has made an outstanding contribution to the field of the Health Sciences, especially in reference to women and particularly in the area of Obstetrics, Gynaecology and Reproductive Medicine.
2. The PRIZE is of an international nature.
3. The PRIZE will have its own jury, made up of the members of the Scientific Committee at the *Dexeus Mujer Foundation*. Winners of preceding calls may subsequently be invited to act as members of the jury.
4. Nominations may be presented by cultural foundations, research centres, scientific universities and associations or any other institutions and personalities, whose members are invited by the jury to do so.
5. Individuals who nominate themselves or the organisation they represent will be rejected.
6. All nominations must be supported by proof of the exemplary nature and importance of the work carried out.
7. The *Dexeus Mujer Foundation* or the jury, instead, will not take any nominations into consideration that do not fulfil these essential requirements.
8. Those interested in opting for this Prize **must make the corresponding application exclusively by e-mail** to the address [fundacion@dexeus.com](mailto:fundacion@dexeus.com), **attaching the application form**, where the detailed instructions and the application form will be found which must be used, duly filled-in and with a detailed statement of the extraordinary merits of the candidacy and its significance.
9. Deadline for nominations, will be **October the 16th, 2023**.
10. Nominations that do not fulfil the above requirements will not be admitted. Moreover, any documentation presented will not be returned nor will any correspondence be exchanged regarding the documentation. All of the nominations received will remain anonymous with the exception of the name of the prizewinner, which will be made known in due time.
11. The chairman of the jury will organise and conduct all deliberations, as well as ensuring that voting takes place according to the voting system.



12. The voting system will be made up of a succession of votes in which the jury choose the candidates it considers worthy of the prize. The votes cast, therefore, will have a positive rather than negative weighting.
13. Votes may not be delegated and must be cast in person by each of the members of the jury. Votes may only be cast by members of the jury who take part in the deliberation procedure. The PRIZE will be awarded to the candidate who obtains the most votes. The chairman will have the deciding vote.
14. A joint PRIZE will only be awarded if it is clear that the person/s or institution are of equal merit.
15. The PRIZE consists of an accredited certificate and an endowment of **7.500 euros**. In the case of a tie, the PRIZE will be equally shared between the prizewinners. In order to receive the certificate and endowment, the prizewinner must collect the prize in person at the prize giving ceremony.
16. The PRIZE is subject to taxes as applicable by law and will be the prizewinner's responsibility.
17. The documentation must be presented in Spanish or accompanied by its corresponding translation into the Spanish if it is presented in a foreign language.
18. The jury's decision will be final and the winner will be immediately informed in writing of its decision.
19. The PRIZE ceremony will take place during the event at which the Foundation's Annual Report is presented. Due warning will be given of the date of this event.
20. The *Dexeus Mujer Foundation* complies in full with the legislation in force as regards personal data protection and, specifically, it maintains the strictest confidentiality in regard to all data received.
21. In order to participate in this call, the rules must be abided by.
